What is a static IP? A static IP address is one that never changes. A few use cases may include, website hosting, eCommerce, virtual private network (VPN), or other remote access solutions.

goBEC Fiber Network offers static IP addresses at \$5.95 per address. A static subnet may be requested, see the attached chart for reference. Please allow up to 5 working days once the request is approved. *Static subnet must have 3 or more IP addresses

goBEC Fiber Network is proud to be able to assign IPv6 addresses. Each location can take advantage of a static IPv6 /48 provided with any static IPv4 assignment at no additional cost. A standalone IPv6 /48 assignment is available on request for \$5.95 per month without justification per location.
